Summary

Our client determined that it was important for them to consolidate their existing content management platforms into a singular cloud-based solution. Their objective was to migrate away from the existing ApplicationXtender 6.5 platform in favor of Microsoft's SharePoint Office 365 hosted solution. This migration would allow them to decommission an on-premise AX system that was difficult to support internally. The project involved the migration of thousands of varying types of documents from ApplicationXtender, along with the content's associated metadata & permissions over to SharePoint Office 365 under extremely tight timelines.

Challenges

Our client's AX migration was relatively straightforward with respect to the extraction of AX content. However, they had large PDF documents. During the consolidation process (Easy2Share - Transformation Phase) the project proved significantly time consuming due to the large PDF documents and related consolidation. In addition, certain types of annotations created issues pertaining to extraction and to some extent imports, though the client didn't need most of them. The Verinon team transformed and rebuilt the relevant metadata in accordance with the client's search related needs. In spite of all noted issues, the migration was delivered on time and on budget.

Solution

In order to meet our client's objectives, Verinon engaged its global migration services team and the Easy2Share Tool Set to accomplish this turnkey migration project.
